

**Region of Queens Municipality
Administrative Policy - 48
Respecting the Closure of a Portion of Main Street
in Liverpool**

WHEREAS Section 315(1) of the Municipal Government Act provides that Council may permanently close any street or part of a street by policy;

AND WHEREAS the Council of the Region of Queens Municipality has determined that a portion of Main Street in Liverpool should be closed;


AND WHEREAS the Region did cause to have published an advertisement in the Queens County Advance on October 4, 2016, giving notice of its intent to close a portion of Main Street in Liverpool;

AND WHEREAS a copy of the notice was sent to the Minister of Transportation and Public Works on September 30, 2016;

AND WHEREAS the proposed closure of a portion of Main Street complies with Section 315 (1A) of the Municipal Government Act and not requiring a public hearing;

THEREFORE, BE IT RESOLVED THAT the Council of the Region of Queens Municipality does hereby close that portion of Main Street described in Schedule "A" and depicted in Schedule "B" attached hereto and forming part hereof, and that all rights of public user in said lands are forever extinguished.

THIS IS TO CERTIFY THAT this Administrative Policy was passed by the Council of the Region of Queens Municipality at a duly constituted meeting of said Council held on the 11th day of October, 2016.

SCHEDULE "A"

ALL THAT certain lot, piece or parcel of land situated, lying and being on the eastern side of Main Street, in Liverpool, County of Queens, Province of Nova Scotia, and being more particularly bounded and described as follows:

BEGINNING at a survey marker being the southeast corner of property of George and Sheila Williams, indentified as PID# 70177744;

THENCE South 34 degrees 7 minutes 40 seconds West, a distance of 28.56 feet to a calculated point;

THENCE North 54 degrees 09 minutes 38 seconds West, a distance of 125.08 feet to a calculated point;

THENCE North 40 degrees 39 minutes 53 seconds East, a distance of 24.99 feet to a calculated point;

THENCE South 55 degrees 52 minutes 20 seconds East, a distance of 122.18 feet to the point of beginning.

THE ABOVE described lot being or intended to be a portion of the Main Street right of way and contain in all 3,302.1 square feet more or less and shown on sketch attached hereto as Schedule "B".

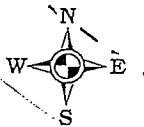
PORTION OF MAIN STREET
